By signing this contract and initialing each of the statements below, I (the participant) and my legal guardian agree to all of the following:

_____ **Participation** – I agree to fully participate in the making of this film given the task I have been assigned, to show up to the set/filming location on time, and to stay until the production is no longer in need of my participation.

_____ **Role Fulfillment** – I agree to learn my lines (if I have any) and practice my role, to show up with my costume, and to be prepared to follow the Director’s instructions. I will make myself available to the Director at what time he/she needs me for the completion of my task on this film. I will make myself available for the postproduction process (ADR, photography shoots, etc) as made necessary by the Director.

_____ **Behavioral Clause** – I commit to following orders, being on my best behavior while filming, and following a code of conduct that is reflective of the BCCHS Student Handbook.

_____ **Professionalism Clause** – I commit to putting aside any high school drama, social issues, or other poor attitudes that are sometimes related to being a high schooler while participating in this production. I understand that I am not part of a common school project, but that this project requires me to act as a mature individual who will bring a professional demeanor to the production.

_____ **Breach of Contract** – If I am found in breach of my contract (not participating, not fulfilling my role, or demonstrating poor behavior or poor work ethic), I understand that I will be fired from my position and will be held accountable for my actions under the authority of Mr. Fairbanks, Mr. Trafton, and the BCCHS Student Handbook.

_____ **Fair Use & Social Media Clause** – I agree that this film can use my image and name in the final production, and the film can be premiered publically, including on the Internet and social media sites.

_____ **Personal Care and Safety:** I agree to attend to my personal care needs by bringing supplies, such as spare clothing, water, snacks, and a lunch (in case we cannot find a sponsor to help cater a lunch for us). This production is in need of participants who are willing to perform some basic stunt work and, when necessary, wear character costumes and make up. I and my legal guardians acknowledge that stunt work is completely voluntary. I and my legal guardians consent that I am responsible for my own safety in avoidance of accidental injury, and any accidental injury is not the fault of BCCHS or PinUp Productions, including but not excluded to the transportation to and from the event and time spent in activities at the event.

_____ **Intellectual Property Rights** – I agree that this production is the intellectual and physical property of BCCHS Film Editing & Design and PinUp Productions. Any amount of income generated from this film does not in any way belong to me, and I will receive no royalties of any kind from the production and distribution of this film.

_____ **Production Equipment Clause (Parents Must Sign!)** – I understand that the student that I am responsible for will be handling expensive equipment as part of this production. If the student breaks, loses, or damages the equipment, I will have the responsibility of repaying the owner(s) of the property in full within thirty (30) days of the occurrence.
